Vendor Registration Fee:

Spaces available: 10ft x 10ft = \$75.00 10ft x 20ft = \$100 20ft x 20ft = \$125.00

Vendors requiring more than one 20ft x 20ft space will be charged at the rate of .25 cents per square foot for the additional space needed. All areas are to be squared off. This includes ramps, tents, trailer tongues, sales areas and any other areas used by the vendor. See diagram.

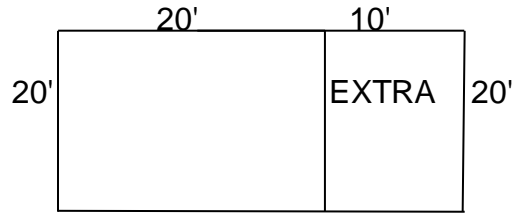
The additional amount for this area would be:
